

## **Terms and Conditions - Helping & Groups**

1. Submitting a nomination for a contribution or submitting a vote for a nominee group constitutes acceptance of these terms and conditions.
2. This program is operated by Police & Nurses Limited, ABN 69 087 651 876, Level 6, 556 Wellington Street, Perth, WA 6000 (**P&N Bank**).
3. By making a nomination, the person making the nomination (**Applicant**) applies for P&N Bank to choose the nominated community or not-for-profit group (**Nominee**) to be featured on a designated webpage, where P&N Bank members can vote for the Nominee to receive a cash contribution from P&N Bank.
4. Nominations may only be made by current members of P&N Bank, who have been members for at least 6 months at the time of making the nomination.
5. Voting on the submissions are available to the members of P&N Bank only.
6. Qualifying members of P&N Bank may only make one nomination per calendar year for a Group Helping &. Each quarter, P&N Bank will choose to accept 10 Nominations received by it, as determined by P&N Bank, and feature them on a designated webpage, where P&N Bank members can vote for the chosen Nominees to receive a cash contribution from P&N Bank
7. P&N Bank members will be able to will be able to vote for their preferred Nominee (from the 10 Nominees for the quarter chosen by P&N Bank) via a designated webpage.
8. Each quarter P&N Bank will award the contributions as following; \$2,000 to the five Featured Nominees with the most member votes. \$1,000 will be awarded to the remaining Featured Nominees.
9. P&N Bank will notify Featured Nominees of the result of member voting in writing within three working days of the end of member voting at their nominated electronic address. The Featured Nominees' details will also be published online at <https://pnbank.com.au/about/community/helping-ands/> within one week of the member vote closing.
10. Prior to P&N Bank making a financial contribution to a Featured Nominee:
  - a. P&N Bank will require the Featured Nominee to specify a bank account to receive a transfer of the relevant amount, which must be in the name of the Featured Nominee;
  - b. P&N Bank will require the Nominee to confirm its identity and existence prior to P&N Bank transferring funds into the Nominee's designated account;
  - c. The Featured Nominee must satisfy the requirements in these terms and conditions to the satisfaction of P&N Bank.
11. P&N Bank may cancel or vary any contribution, at the discretion of P&N Bank.
12. Where a Featured Nominee has not satisfied the requirements in these terms and conditions to receive a contribution within six months of being notified by P&N Bank of the result of member voting, the contribution will be cancelled.
13. Featured Nominees must agree to refrain from allowing any banks, financial institutions, financial planning advisors, Credit Societies, Credit Unions or

organisations promoting mortgage and personal loan products from becoming a major sponsor of the Featured Nominee for the calendar year of this contribution.

14. Featured Nominees are not entitled to use the name or any marks of P&N Bank without the prior consent of P&N Bank. Featured Nominees must seek and receive approval from P&N Bank (with at least 48 hours advance notice) before publishing any material with the P&N logo on it.

15. Featured Nominees must not make a profit that benefits an individual.

16. Featured Nominees must agree to participate and cooperate as required in all editorial activities relating to the contribution, including but not limited to being interviewed and photographed. Featured Nominees (and their representatives) must grant P&N Bank a perpetual and non-exclusive licence to use such footage and photographs in all media worldwide, including online social networking sites, and the Featured Nominee (and its representatives) will not be entitled to any fee for such use.

17. As part of a nomination P&N Bank will request some basic information and a photo of the Nominee. These details and photograph will be displayed on the <https://pnbank.com.au/about/community/helping-ands/> for members to view during the voting and for the general public to view once the contribution has been awarded. By providing this image to P&N Bank, the Applicant and Nominee grant their consent to the information and the photo being published on the website <https://pnbank.com.au/about/community/helping-ands/>

18. P&N Bank may change the voting dates for members when necessary.

19. P&N Bank is not liable for any losses, injury or damage that may occur directly or indirectly from the use of any contributions.

20. P&N Bank's decision in relation to any aspect of the contributions is final. No correspondence will be entered into.

21. P&N Bank reserves the right to amend these terms and conditions at any time.

23. Groups nominated must operate primarily in Australia and the contribution must benefit Australian based initiatives.
