

## **Terms and Conditions - Helping & Individuals**

1. Submitting a nomination for a contribution constitutes acceptance of these terms and conditions.
2. This program is operated by Police & Nurses Limited, ABN 69 087 651 876, Level 7, 130 Stirling Street, Perth, WA 6000 (**P&N Bank**).
3. By making a nomination, the person making the nomination (**Applicant**) applies for P&N Bank to make a contribution to the nominated person (**Nominee**) of cash or services.
4. Nominations may only be made by current members of P&N Bank, who have been members for at least 6 months at the time of making the nomination.
5. A Nominee does not need to be a member of P&N Bank.
6. Qualifying members of P&N Bank may make up to 4 nominations per calendar year.
7. Qualifying members of P&N Bank may only make one nomination in respect of the same Nominee per calendar year.
8. Each month, P&N Bank will choose to accept one or more Nominations received by it, as determined by P&N Bank, and decide to provide cash or services to the relevant Nominees.
9. The amount of cash or services to be provided by P&N Bank to a Nominee where P&N Bank chooses to accept a nomination will be determined by P&N Bank in its discretion.
10. P&N Bank will notify Applicants whose Nominations are accepted by P&N Bank in writing within five working days of the final decision, at the Applicant's nominated electronic address.
11. Where P&N Bank chooses to make a financial contribution to a Nominee, :
  - a. P&N Bank will require the Nominee to specify a bank account to receive a transfer of the relevant amount, which must be in the name of the Nominee; and
  - b. P&N Bank will require the Nominee to confirm their identity prior to P&N Bank transferring funds into the Nominee's designated account.
12. Where P&N Bank chooses to make a contribution of services to a Nominee, P&N Bank will contact the Nominee and/or their family to make the necessary arrangements.
13. P&N Bank may cancel or vary any contribution it has decided to make, at the discretion of P&N Bank.
14. Where a Nominee has not satisfied the requirements in these terms and conditions to receive a contribution within six months of being notified that P&N Bank has accepted their Nomination, the contribution will be cancelled.
15. Contributions are not transferrable.

16. Where appropriate and only after consultation with both the Applicant and the Nominee, successful Nominees may be asked to participate and cooperate in editorial activities relating to the contribution, including but not limited to being interviewed and photographed. The successful Applicants and Nominees (and their companions) grant P&N Bank a perpetual and non-exclusive licence to use such footage and photographs in all media worldwide, including online social networking sites, and Applicants and Nominees (and their companions) will not be entitled to any fee for such use.
17. P&N Bank is not liable for any losses, injury or damage that may occur directly or indirectly from the use of any contributions provided.
18. P&N Bank's decision in relation to any aspect of the contributions is final. No correspondence will be entered into.
