General Conditions

I/We as the Authorised Signatory(ies) on behalf of the Business Owner/Customer accept and agree to the following:

- "Information" means all account balance and transaction details for the Nominated Accounts. The account balance will be that at the date and time the Information is transmitted by the Data Provider.
- No relationship of agency, partnership, joint venture or any other similar relationship exists between the Data Provider and Data Recipient, and the Data Provider accepts no responsibility for the actions, omissions, fraud or negligence of the Data Recipient or any other third party.
- The Business Owner/Customer requests and authorises the Data Provider to release the Information to the Data Recipient as often as the Data Recipient requests the Information, and as often as the Data Provider can provide it, subject to the agreement between the Data Provider and Data Recipient. The Business Owner/Customer accepts and acknowledges that information provided to the Data Recipient may be held by the Data Recipient in locations overseas i.e. United States of America and or other locations that may be used by the Data Recipient from time to time.
- The Information will be disclosed by electronic transmission to the Data Recipient. The Business Owner/Customer accepts and acknowledges that electronic services are subject to interruption or breakdown for a variety of reasons.
- Neither the Data Provider nor the Data Recipient will, subject to any prohibition or limitation imposed by law, be liable in contract, tort (including negligence) or otherwise for any damage, loss or cost (including legal costs) to the Business Owner/Customer or any other person caused or arising out of any act or omission by either the Data Provider or the Data Recipient in relation to this Authority.
- The Business Owner/Customer agrees to indemnify and hold the Data Provider and Data Recipient harmless against any loss, damage, cost, expense, claim, proceeding or liability of whatever kind, other than arising from negligence or fraud by the Data Provider or the Data Recipient or any of their employees, which the Data Provider or Data Recipient may suffer or incur to any person as a result of the Data Provider or Data Recipient acting on the Business Owner's/Customer's instructions set out in this Authority.
- The Data Provider will not be liable to any person for their reliance on any Information supplied to the Data Recipient, or any failure by the Data Provider to provide Information or to provide complete or accurate Information to the Data Recipient.
- The Data Provider may, in its sole discretion, on any grounds it thinks fit, and without rendering the Data Provider or Data Recipient liable in any way, discontinue the provision of Information to the Data Recipient pursuant to this authority.
- The Business Owner/Customer may terminate this authority at any time on providing 2 business days' written notice to the Data Provider.

This Authority will continue in full force and effect until the Data Provider receives notice in writing from the Business Owner/Customer cancelling it.
